ORDER

This matter is before the Medical Licensure Commission of Alabama on the request of Dr. Oliver to restore his license to practice medicine in Alabama, DO.2104, to full, unrestricted status. The Commission notes that, by Order of May 23, 2022, the Alabama Board of Medical Examiners removed all restrictions previously attached to Dr. Oliver's Certificate of Qualification, and reinstated his Certificate of Qualification to full, unrestricted status.

Therefore, it is the ORDER of the Medical Licensure Commission of Alabama that all restrictions and conditions on Dr. Oliver's license to practice medicine in Alabama, DO.2104, are hereby removed, and said license is restored to full, unrestricted status.



ORDER

This matter is before the Alabama State Board of Medical Examiners on a request by CRAIG C. OLIVER, D.O., for removal of the voluntary restriction placed on his certificate of qualification for a license to practice medicine or osteopathy in Alabama on November 21, 2019. The Alabama State Board of Medical Examiners hereby finds that CRAIG C. OLIVER, D.O., is qualified to possess an unrestricted certificate of qualification and license to practice medicine or osteopathy in the state of Alabama.

Therefore it is the ORDER of the Alabama State Board of Medical Examiners that the Voluntary Restriction dated November 21, 2019, currently attached to the certificate of qualification and license to practice medicine or osteopathy in Alabama, license number DO.2104, of CRAIG C. OLIVER, D.O., be removed, that all restrictions heretofore entered against his certificate of qualification and license to practice medicine or osteopathy in Alabama be terminated, and that the certificate of qualification of CRAIG C. OLIVER, D.O., be reinstated to full, unrestricted status.

ORDER

This matter comes before the Medical Licensure Commission of Alabama on the Motion to Alter, Amend, or Vacate Order submitted by the Alabama State Board of Medical Examiners (the Board). In that motion, the Board correctly points out that some of the restrictions on Dr. Oliver's license to practice medicine were imposed upon Dr. Oliver's Certificate of Qualification (COQ) issued by the Board by way of voluntary restrictions. The Commission's prior Order of June 30, 2021, purported to lift the probationary status on the license and, with it, all of the restrictions on the license, including the voluntary restrictions on the COQ imposed by the Board. Section 34-24-361(g) requires that "If the Board attaches restrictions to a physician's or osteopath's certificate of qualification . . . the commission shall also place the restrictions on the physician's or osteopath's license to practice medicine . . ." Ala. Code § 34-24-361(g) (1975). The Commission's Order of June 30, 2021, therefore, is due to be vacated.

Further review of the voluntary restrictions reveals that one of the said voluntary COQ restrictions was not encompassed in the Commission's original Order of January 15, 2020, which granted a probationary license with restrictions. More specifically, the voluntary restrictions agreed to by Dr. Oliver on or about November 21, 2019, included the following:

- 4. I agree to provide to the Board, upon request, blood and/or urine and/or hair samples for the purpose of laboratory testing to determine the presence of alcohol, controlled substances, and/or

mood-altering substances, and I understand and acknowledge that I shall be responsible for the expense of said testing. I understand and agree that a refusal by me to provide a blood and/or urine and/or hair sample to the Board upon request shall constitute a violation of this Voluntary Restriction.

It is apparent to the Commission that this restriction is intended to be part of the Board's monitoring of Dr. Oliver and is a separate requirement from the other restrictions which are encompassed in Dr. Oliver's agreement with the Alabama Professionals Health Program (APHP). The Commission's original Order of January 15, 2020, therefore, is due to be amended to include the above-referenced restriction.

Dr. Oliver's most recent request to lift restrictions on his license was a request to lift the restriction on his license which limited his practice to the University of South Alabama's Internal Medicine Residency Program. That request is due to be granted.

It is therefore, ORDERED, as follows:

1. The Commission's Order of June 30, 2021, purporting to lift the probation on Dr. Oliver's license to practice medicine is hereby VACATED.

2. The Commission's Order of January 15, 2020, is hereby AMENDED so as to delete the restrictions and/or probation placed upon his license and for those restrictions to be replaced in their entirety as set out below. Dr. Oliver's license to practice medicine, therefore, shall be and is hereby restricted as follows:

A. Dr. Oliver shall maintain his contract with the Alabama Physician's Health Program (APHP) in good standing until released by APHP and the Board, and he shall abide by all of the terms of that contract, including submission to alcohol/drug screenings and/or polygraph testing which APHP may require from time to time under that agreement;

B. Dr. Oliver shall abstain from using any and all mood-altering and/or potentially addictive substances, drugs, and/or chemicals, whether scheduled, non-scheduled, or over the counter, except as prescribed by a physician and in accordance with the terms of the APHP agreement;

C. During the period of the Voluntary Restrictions on his COQ agreed-to by Dr. Oliver, he shall notify the Board of any change of residence address and any change in medical practice location or employment, and shall provide the reason for such change;

D. Dr. Oliver shall execute and, until such time as the MLC lifts the restrictions or Dr. Oliver's license otherwise terminates, keep in effect a valid consent which complies with the requirements of 42 C.F.R. Part 2.


This matter came before the Medical Licensure Commission of Alabama on November 22, 2019 on an application for licensure to practice medicine or osteopathy in the state of Alabama submitted by Craig C. Oliver, D.O.

On November 22, 2019, the Commission found that the application was due to be and was GRANTED on a probationary basis subject to the following terms of probation:

- A. Dr. Oliver shall be restricted to practicing medicine or osteopathy only under the auspices of and under the supervision of attending physicians in the University of South Alabama's Internal Medicine Residency Program.
- B. Dr. Oliver shall maintain his contract with the Alabama Physician's Health Program (APHP) in good standing and abide by all of the terms of that contract, including alcohol/drug screenings which APHP may require from time to time.
- C. Dr. Oliver shall be monitored and tested by way of a Soberlink device for a period of one year at a frequency to be determined by the MLC in consult with APHP. Such testing shall be additional to the alcohol/drug testing required by Dr. Oliver's contract with APHP, but shall be administered and reviewed by APHP.

D. Dr. Oliver shall execute and, until such time as the MLC lifts the probation of Dr. Oliver's license or Dr. Oliver's license otherwise terminates, Dr. Oliver shall keep in effect a valid consent which complies with the requirements of 42 C.F.R. Part 2.

VOLUNTARY RESTRICTION ON CERTIFICATE
OF QUALIFICATION AND LICENSE TO PRACTICE MEDICINE

The undersigned, CRAIG C. OLIVER, D.O., does hereby voluntarily request and consent that the following restrictions be placed upon his certificate of qualification and license to practice medicine in Alabama, license number DO.2104 .

These restrictions are voluntarily entered upon by me, I sign this document willingly, I execute it as my free and voluntary act for the purposes herein expressed, and I am of sound mind and under no constraint or undue influence. I understand and agree that these voluntary restrictions shall continue in full force and effect until they are modified, amended, or terminated by the Alabama Board of Medical Examiners (“the Board”) at my written request.

RESTRICTIONS

1. I agree to maintain an Assistance Agreement with the Alabama Professionals Health Program (“APHP”) until released from this restriction by APHP and the Board. I agree that I shall fully comply with and abide by the terms and conditions set forth in that Assistance Agreement.
2. I understand that the terms and conditions of the APHP Assistance Agreement shall include urine, blood, and/or hair testing and/or polygraph testing at frequencies determined by the APHP and the monitoring/assistance agreement, and I hereby agree to submit to urine, blood, and/or hair testing and/or polygraph testing as required by the APHP Assistance Agreement.
3. I agree that I shall abstain from using any and all mood-altering and/or potentially addictive substances, drugs, and/or chemicals, whether scheduled, non-scheduled, or over-the-

counter, except as prescribed by a physician and in accordance with the terms of my APHP monitoring/assistance agreement.

4. I agree to provide to the Board, upon request, blood and/or urine and/or hair samples for the purpose of laboratory testing to determine the presence of alcohol, controlled substances, and/or mood-altering substances, and I understand and acknowledge that I shall be responsible for the expense of said testing. I understand and agree that a refusal by me to provide a blood and/or urine and/or hair sample to the Board upon request shall constitute a violation of this Voluntary Restriction.

5. During the period of this Voluntary Restriction, I shall notify the Board of any change of my residence address and any change in my medical practice location or employment and shall provide the reason for such change.

PENALTIES FOR VIOLATION


The failure or refusal to satisfy any one or more of the requirements and conditions stated in paragraphs 1 through 5 shall constitute a violation of this Voluntary Restriction. Any violation of this Voluntary Restriction, if established after notice and hearing as provided by the Alabama Administrative Procedure Act and the Rules and Regulations of the Medical Licensure Commission, shall constitute grounds for the suspension, restriction, or revocation of the named physician's license to practice medicine in Alabama or the imposition of any other penalty authorized by Ala. Code §§34-24-361 and 34-24-381(2002).

DISCLOSURE NOTICE

This Voluntary Restriction constitutes a public record of the Alabama Board of Medical Examiners and will be reported by the Board to the Federal National Practitioner Data Bank and the Federation of State Medical Boards disciplinary data bank. This voluntary restriction may be released by the Alabama State Board of Medical Examiners to any person or entity requesting information concerning the licensure status in Alabama of the physician named herein.
